



## FREQUENTLY ASKED QUESTIONS

### What is Founders' Day of Giving?

Founders' Day of Giving is 48-hours for Phi Psis, family and friends to join in support of our undergraduate fraternity experience. On this day, we honor Founders William Henry Letterman and Charles Page Thomas Moore who started a Brotherhood that continues to impact thousands annually.

### What is the goal?

In honor of Phi Psi's 167th year, our goal is to inspire at least 167 donors to make a Founders' Day gift to support our undergraduate brothers. Additional goals and challenges will be announced throughout Day of Giving via email and on the Phi Psi Foundation's social media channels.

### When can I make my gift?

Mark your calendar and make your gift between **12:00am EST February 18 and 11:59pm EST February 19!**

### Is there a minimum or maximum gift I can make?

The minimum gift we can process through our website is \$5. There is no maximum gift amount for Founders' Day — the sky's the limit! Gifts typically range from \$18.52 up to \$1,852, but all gifts are encouraged.

### What will my gift support?

Your contribution to Founders' Day of Giving will be invested back into the Brotherhood this year through grants made to support Fraternity led leadership programming that strengthens Phi Psi and its undergraduate members.

### Is my donation tax-deductible?

Phi Kappa Psi Foundation (EIN 36-6130655) is a charitable and educational 501(c)(3) organization classified by the Internal Revenue Service. Donations to the Foundation are tax-deductible in the United States as allowed by law.

### **Will I receive a tax receipt for my donation?**

Upon making your gift online, you will receive an emailed acknowledgement that contains your tax receipt. If making your gift via phone or mail, you will be mailed an acknowledgement letter after your gift has been processed.

Matching gifts made by your employer are a great way to make your generosity go the extra mile. To make a matching gift, please contact your employer's HR department.

### **Can I make a gift to support my chapter?**

While unrestricted gifts to the Phi Psi Fund are highly encouraged to fund grants for Fraternity programming that support all our undergraduate brothers, you are welcome to write in a gift designation in the "Comment" field. Matching and challenge gift funds will be designated to the Phi Psi Fund.
